PROJECT AGREEMENT

This agreement is made between **ONE DOLLAR PROJECT INC** and **FAMILY RESOURCE CENTRE (FRC)** of P.O. BOX 20809-00202, NAIROBI KENYA.

Both parties agree that their conduct in this agreement will be according to the principles of Islam derived from the Quran and the Sunnah of Prophet Muhammad (S.A.W).

The terms of this agreement are stipulated below:

1. THE PROJECT

The project is to establish income generating activities through micro-financing for persons who are in need and are suffering from HIV AIDS or groups of person among whom are members who are suffering from HIV AIDS to enable them to meet their daily needs and establish themselves financially.

FRC is to conduct a thorough evaluation and selection processes to identify persons who are in need of such projects and who are most likely to benefit from it and ensure its continuity in benefiting the community as a whole.

FRC has identify two groups of five women and five men among who are persons suffering cronstilly AIDS who have expressed interest in participating in the project.

Each person shall be financed are a rate of AU\$ 190.00 (One Hundred and Ninety Dollars Ponly) and is expected to repay the amount between 3 (three) to 4 (four) months after receiving the funds.

Persons who are experiencing financial difficulty and are not able to repay the amount and FRC established this to be true, then the person is free from any debt and the amount is considered as forgiven.

3. REPAYMENTS

Repayments are to be paid to FRC who will use the funds to assist other persons in need and continue the micro-financing project.

4. OWNERSHIP OF THE PROJECT

20th parties have agreed to entrust FRC as the trustee and regulator who will, to the best of their ability, ensure the continuity of the project to benefit the community as a whole.
