## **PROJECT AGREEMENT**

This agreement is made between **ONE DOLLAR PROJECT INC** and **ALMUNTADA DEVELOPMENT PROJECT** of **P.O. BOX 26650-00504, NAIROBI KENYA**.

Both parties agree that their conduct in this agreement will be according to the principles of Islam derived from the Quran and the Sunnah of Prophet Muhammad (S.A.W)

The terms of this agreement are stipulated below:

#### 1. THE PROJECT

The project is to rebore/sink a shallow well complete with hand pump and floor at a cost of US\$ 2,000.00 (Two Thousand US Dollars Only). Once established, the project is expected to meet two conditions;

- a) It is to sustain itself by meeting its day to day running cost and
- b) It is to benefit the community in its locality and not charge for water use.

#### 2. LOCATION OF PROJECT

The project is to be established in RUMBIYE VILLAGE, RUMBIYE SUB-LOCATION, NANGUDA LOCATION, FUNYULA DIVISION, SAMIA SUB-COUNTY – BUSIA COUNTY - KENYA. The land where the project will be constructed/drilled will be on the property of MEMBERS OF PUBLIC CONSUMPTION. Written permission has been sought from WINSLAUS O. OCHARA (ASSISTANT CHIEF – RUMBIYE SUB-LOC.) being the legal owners/carer of the property, authorising the sinking of the shallow well and agreeing with the two conditions set in point 1.

#### 3. OWNERSHIP OF THE PROJECT

Both parties have agreed to entrust AlMuntada Development Project as the trustee and regulator who will, to the best of their ability, ensure the project meets the two main objectives of self-sustainability and benefit to the community.
