PROJECT AGREEMENT

This agreement is made between **ONE DOLLAR PROJECT INC** and **PARK ROAD YOUTH GROUP.**

The terms of this agreement are stipulated below:

1. THE PROJECT

The project is to provide food ration to fasting families in the month of Ramadhan in the year 2016 which is expected to start 06^{th} or 07^{th} June 2016. Food ration per family is to contain the following items;

- i. 5 Kgs of Wheat flour
- ii. 5 Kgs of Maize flour
- iii. 10 Lts of Cooking oil
- iv. 0.5 Kg of Tea Leaves
- v. 15 Kgs of Rice
- vi. 0.4 Kgs of Salt
- vii. 7 Kgs of Sugar
- viii. 4 Kgs Spaghetti

2. FUND TRANSFER

All funds collected by One Dollar Project Inc are to be transferred through telegraphic transfer to Alpha Grain Miller Ltd who are the suppliers of the food items mention in point number 1 above. All funds transferred are to be used for the sole purpose of the project.

3. LOCATION OF PROJECT

The project is to distribute food ration to families in Kenya where majority of the families live in Nairobi and its environs.

4. OWNERSHIP OF THE PROJECT

The project is a joint effort between the two parties and both parties, One Dollar Project Inc and Park Road Youth Group, agree to have a joint ownership over the project.
